

Conditions of participation BMW MOTORRAD ENDURO PARK

- It is my own risk to participate in this offroad training at BMW MOTORRAD ENDURO PARK (Am Enduro Park 1, 91719 Hechlingen am See, Germany) and I am aware of the increased risk of accidents.
- TWTMoto GmbH is only liable for damage caused intentionally or through gross negligence.
- If I participate in this offroad training course at the BMW MOTORRAD ENDURO PARK (Am Enduro Park 1, 91719 Hechlingen am See, Germany) with my own vehicle, TWTMoto GmbH shall be indemnified against all claims in connection with damage to this vehicle and damage to other participants or other third parties, except in the case of damage caused intentionally or through gross negligence by TWTMoto GmbH. Furthermore, my vehicle is in perfect technical condition with an appropriate standard exhaust system and has a valid registration as well as liability insurance with sufficient cover.
- During training, I will wear suitable protective clothing (helmet, motorcycle jacket and pants with protectors, gloves, boots).
- I confirm that I am mentally and physically fit to take part in this training and that I will not consume alcohol or other psychotropic substances that could impair consciousness and perception before and during the training.
- I agree that I cannot participate in the training without a valid driver's license, which must be presented to TWTMoto GmbH on the day of the training together with an identification document (ID or passport).
- I will follow the instructions of TWTMoto GmbH without fail, otherwise I will be excluded from the training. TWTMoto GmbH alone reserves the right to decide on this.
